Strategies for Optimisation and Variance Reduction in Method Development & Validation

Abstract: The process of validating a new assay or method ("is the assay/method/... fit for its purpose") inevitably requires regulatory aspects to be addressed and acceptance criteria to be satisfied. Statistical procedures such as Design of Experiments (DoE) and variance component estimation should, however, be adopted further upstream during the development phase - indeed, this is recommended by the regulatory authorities. The presentation will describe how such techniques can be applied during the development and validation stages in a structured and sequential fashion using simple software tools in order to prevent problems and/or failure to comply, rather than troubleshooting and late fixes.

Speaker: Ian MacPherson has over 20 years experience in the pharmaceutical industry, having supported various areas of non-clinical research and development and seen various mergers and harmonisations with Wellcome, SmithKline & French, Beecham and finally SmithKline Beecham. He left a management role in the latter just over a year ago to form PRISM Training & Consultancy Ltd with a colleague, aimed at supporting experimenters in any research, development or manufacturing environment through provision of training, consultancy and software development.
