# Reflections on a career as a professional statistician and the increasing value of the role of professional bodies

# Trevor Lewis, PhD, CStat, CSci, PStat

Director, TLwise Consulting Limited and RSS Theme Director for Professional Affairs

Abstract: This presentation is focused on statisticians rather than statistical science. Trevor will provide a personal perspective on the challengers of switching direction during a career as a statistician from working in academia to statistical consulting in the pharmaceutical industry; and then switching from a senior management role in a multinational pharmaceutical company to working as an independent statistical consultant. In parallel to pursuing a career there are opportunities to support your profession by taking on volunteer roles within your professional body. Trevor will talk about his experiences participating in activities with the Royal Statistical Society (RSS) and the direction currently being taken to enhance the RSS as a professional body for statisticians. He will cover recent developments in the Chartered Statistician award, the evolution of the RSS professional pathway to encourage and support careers in statistics and the introduction of the Professional Statisticians' Forum.

**Speaker:** Trevor Lewis has had a career as a statistician in academia, the pharmaceutical industry and most recently as an independent statistical consultant. He has a PhD in Mathematical Statistics from the University of Birmingham, UK (1974), has been a Chartered Statistician (CStat) since 1993, a Chartered Scientist (CSci) since 2009 and an ASA Accredited Professional Statistician (PStat) since 2010. Trevor held positions of increasing responsibility in Pfizer, a multinational pharmaceutical company, from 1982 to 2004; initially as a senior statistical consultant and progressing to Vice President of Development Operations. As well as supporting the progression of several important medicines to worldwide registration, he led major change initiatives to introduce new technology, globalise operations and integrate organisations following mergers. From 1991 to 2001 he was a member of several UK (ABPI), European (EFPIA) and international (ICH) pharmaceutical industry statistical expert working groups; including the ICH-E9 (Statistical Principles for Clinical Trails) Expert Working Group. Since 2004 he has worked as an independent statistical consultant (Director, TLwise Consulting Limited) providing services primarily to biotechnology companies. Trevor has been active for many years in the Royal Statistical Society being Vice-President and Chair of the Professional Affairs Committee (1998-2000, 2011-2012) and is currently Theme Director for Professional Affairs. Since 2011 Trevor has also been active in the work of the Science Council, chairing their CPD learning group and as a member of the Registration Authority.
